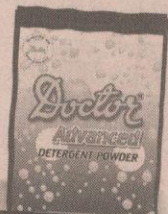

Accordingly, the figures for the year ended March 31, 2025 include the results of Suraj Bhan Agencies Limited only from the date of acquisition and are therefore not comparable with the previous year's figures. (5) Figures for the previous period have been regrouped wherever necessary, to conform to the current period's classification. (6) The Board of Directors of the Company has recommended a final Dividend @ 30% i.e. Rs. 3.00 per Equity Share of the face value of Rs. 10 each for the Financial Year 2024-25 subject to the approval of the share holders at the ensuing Annual General Meeting.
